Sub: Conduct of Special Physical Inspection in SARAS system - reg.


Consequent upon approval of the Affiliation Committee in its meeting held on 29.11.2022 at Agenda Item No. – IX and subsequent ratification by the Governing Body of the Board in its meeting held on 28.12.2022 at Item No. IV, in order to verify the genuineness of the land area, physical infrastructure and academic parameters even after undergoing the process of inspection through physical and virtual mode, by the Inspection committee and Review Committee respectively the "Special Physical Inspection" shall be enabled in the SARAS Portal.
