Consequent upon recommendations of the Affiliation Committee made in its meetings held on 24.6.2013 and subsequently approval of the Governing Body of the Board in its meeting hald on 28.8.2013, the following amendments/additions in Affiliation Bye-Laws of the Board have been made by the Board:-
