**Sub: Sale of AIDS awareness stamps in CBSE schools for resource mobilization to rehabilitate child victims of HIV - reg.**



This is in continuation to this office circular No. CBSE/ AFF/2012/02 dated 01.11.2012.

The Board has been informed that Global Kerala Initiative-Keraleeyam is a major Charity organization in Kerala working for the rehabilitation of the neglected and orphan HIV Positive children in India. The CBSE vide circular referred to above permitted Keraleeyam to distribute AIDS awareness stamps worth ₹ 5/- only in the schools affiliated to CBSE only in Kerala during the current academic year ending on March 2013.

The Chairman, Keraleeyam has requested that the organization may be given permission to distribute stamps in the schools affiliated to CBSE purely on voluntary basis.

On the basis of the request of the Chairman of Global Kerala initiative- Keraleeyam, the Principals of the all the schools affiliated to CBSE in Kerala are requested to cooperate and participate in this noble endeavour by accepting the stamps which will be distributed to the schools by Keraleeyam. The collection period will be limited to the end of this academic year i.e. March 2014 and the sale of stamps will be only through the Principals of the schools concerned. Detailed accounts regarding the printing, distribution and sale of stamps shall be subjected to audit of the Government of Kerala.
