Subject:- Debarment from taking admission in Class XI & XII w.e.f. 01.04.2017 for two academic sessions i.e. 2017-18 and 2018-19 in King N Queens World School, Main Avati Mar, Near Iskcon Temple, Kanpur, UP 208002 - reg.

Sir/Madam,

CBSE/Aff./SS-00797-This is with reference to this office letter no. 1516(2131640)/2016/1138418 dated 28.09.2016 regarding Upgradation of King N Queens World School, Main Avati Mar, Near Iskcon Temple, Kanpur, Uttar Pradesh-208002 to Senior Secondary level w.e.f. 01.04.2016 to 31.03.2019 for a period of three years and subsequent directions of Hon'ble High Court of Allahabad vide order dated 28.02.2017 in Writ C No.6469 of 2017 restraining the above school from taking admission of students in class XI & XII for next session 2017-18 without seeking approval and sanction from the CBSE.

In this connection, it is to inform that this office vide letter dated 28.09.2016 has granted Upgradation to Senior Secondary level for a period of three years w.e.f. 01.04.2016 to 31.03.2019 with permission to start class XI w.e.f. 01.04.2016 so that first batch of class XII shall appear in AISSCE- 2018. The school vide letter dated 18.11.2016 has requested to accord special permission for 29 students of class XII for appearing AISSCE-2017.

As per provisions contained in Rule no. 15.9 of Affiliation Bye Laws of the Board "No School is permitted to start CBSE Pattern Classes VI/IX/XI as the case may be without obtaining formal permission of affiliation of the CBSE. Any school who violates the condition would be disqualified for a period of two years".

The Kings N Queens World School without obtaining affiliation with the Board for Senior Secondary level has started classes XI/XII and hence violated the above provisions willfully and concealed the same at all stages of processing of its application for up gradation to +2 stage. The same enrolment of Class XI students for academic session 2015-16 was concealed from the Inspection Committee which conducted the Inspection of the school on 17.10.2015 to consider the suitability of the school for Senior Secondary affiliation.

This act of the school has not only inconvenienced the Board but also put in danger the academic career of 29 students. In compliance to directions of the Hon'ble High Court of Allahabad, the Board has accorded special permission to these 29 students of class-XII to appear in AISSCE 2017 from Heritage International School, Kanpur. Further, in compliance to orders of Hon'ble High Court of Allahabad, the King N Queens World School, Main Avati Mar, Near Iskcon Temple, Kanpur, Uttar Pradesh-208002 is restrained from taking admission of students in class XI and XII for the next session 2017-18 without seeking approval and sanction from CBSE.

In view of violation of rule 15.9 of Affiliation Bye Laws of the Board and in compliance to directions of Hon'ble High Court of Allahabad vide order dated 28.02.2017, the school is hereby debarred for a period of two years(i.e., two academic session 2017-18 and 2018-19) from taking admission in classes XI and XII. However, the existing students of class XI shall be permitted to appear in All India Senior Secondary Certificate Examination (AISSCE) 2018. The school will also submit an affidavit duly notarised to the effect that the school shall sponsor only regular and bonafide students of the school for AISSCE 2018 and they are eligible as per prescribed norms of Examination Bye Laws of the Board.

In view of above, the school is hereby directed to abide by the above directions meticulously, failing which the school shall be disaffiliated for Secondary and Senior Secondary level as per Rule 17 of Affiliation Bye Laws of the Board without giving further notice and the school shall be responsible for any consequences arising out of it.
