The Heads of all Affiliated Schools.

Sub:-Relieving of teachers nominated by CBSE for the Evaluation of Answer Scripts of Board Examinations –reg.

This is in continuation to the Board's Circular no. 25 (Affiliation) dated 18.12.2017 on the subject cited above, vide which clear directions were given to the schools to relieve the teachers nominated by CBSE for evaluation of answer scripts. It was also laid out in clear terms that any non-compliance will be seen as misconduct in connection with the examinations and penalty and /or further action of disaffiliation will be taken against the school.

It is again to bring to the knowledge of management and heads of all the affiliated schools that the Board's examinations are to start with effect from 05.03.2018 and the evaluation of the answer scripts will start concurrently. It is expected that all the schools have already registered their teachers as mandated in the circular and filled the teacher's database.

It has been observed in the past that the schools adopt lax attitude in relieving the teachers for duties in connection with evaluation of answer scripts thereby hampering and jeopardizing the whole process of evaluation and result processing. Schools are hereby reminded that this also impacts upon the quality of evaluation, thereby impacting on the future of the children.

Therefore, schools affiliated with CBSE are hereby directed to relieve all the teachers nominated by the Central Board of Secondary Education strictly as per the schedule communicated for training and relieving of such nominated teachers.

The non-compliance of these directions will be viewed seriously and a **penalty alongwith** all or any of the following will be imposed upon the school:

1. Withholding the application of school for Extension/Upgradation/Additional Subjects etc.
2. Action as per Rule 17.2(a)(xi) of Affiliation Bye-Laws.
