**Subject – Extension of timeline for application under various categories for the session 2022-23 under SARAS.**

In continuation to the earlier Circular No.01/2021 dated 07.01.2021, pertaining to the Re-structuring of CBSE Affiliation System w.e.f March 2021 under SARAS (School Affiliation Re-engineered Automation System) and subsequent timeline mentioned in the SARAS manual for various categories of affiliation for the session 2022-23.

In this connection, the Competent Authority of the Board after due consideration and reviewing the current COVID-19 situation has extended the first window period of online application for Fresh Affiliation, Up-gradation of Affiliation and Extension of Affiliation till 30.06.2021 for the session 2022-23 without any late fees.

Therefore the revised/extended timelines for the session 2022-23 are as follows;
