Subject: -Minimum requirement of 40 computer system in Computer Science Lab in the school - reg.

The affiliated schools of the Board are expected to equip themselves with the latest technology. The computer literacy for the students and online teaching is need of the hour.

In this connection reference to the Circular No. 10/ 2023 dated 24.03.2023 is invited for Implementation of Digital Infrastructure in CBSE Schools, wherein minimum requirement of 40 Computer Systems has been prescribed for Computer Science laboratory in affiliated schools minimum 40 computers with internet connectivity and other accessories are to be provided to the students. It has been noticed that many affiliated schools are not adhering to the above guidelines or providing correct details. It is reiterated that the affiliated schools must maintain minimum 40 Computer System in working condition, with prescribed accessories as mentioned in said circular in the Computer Science Labs.
