**Notification**

**Subject: Module for Schools regarding change in nature of managing entity of School from inter-se Society/ Trust/ Company to another legal entity without change in involving management in the SARAS 7.0- reg.**

As per the recommendation of the Affiliation Committee in its Meeting held on 26.11.2025 vide Agenda Item XVII, ratified by the Governing Body in its Meeting held on 24.12.2025 vide Agenda Item IV and subsequent approval of the Controlling Authority of the Board, the following amendment has been incorporated in chapter 15(Special Provisions) of Affiliation Bye-Laws 2018 of the Board regarding change in nature of School management inter-se from Society/ Trust/ Company to another entity are hereby notified:

<b>15.11</b>	<p><b>CHANGE IN NATURE OF MANAGING ENTITY OF SCHOOL</b> A school affiliated with the Board may apply for change in nature of School management inter-se from Society/ Trust/ Company to another Legal entity without change in management for approval of the Board subject to submission of the following documentary proof:</p> <p><b>15.11.1</b> Specific approval for change in nature of managing entity of school from the State Government;</p> <p><b>15.11.2</b> Registration/Certificate of new entity from the respective issuing Authority like Registrar of Society/Company/Charity Commission;</p> <p><b>15.11.3</b> System Generated Self- certification signed by principal &amp; Manager of the school and duly countersigned by the authorized signatory;</p> <p><b>15.11.4</b> Fees equal to existing fee for change of name of Society/ Trust/Company shall be approved.</p>
