Subject: - Extension of timeline for submission of applications by existing schools under some categories of affiliation for the session 2024- 25 in SARAS 4.0- reg.

The Board had issued Circular No. 17/2023 dated 28.04.2023 regarding submission of applications under various categories of affiliation for the session 2024- 25 in SARAS 4.0 portal upto 30th June, 2023. The timeline for submission of application was extended to all the existing schools vide Circular No. 19/2023 dated 23.06.2023 upto 31st July, 2023.

In this connection, the Board after due consideration has decided to extend the timeline for submission of the online applications for the session 2024- 25 in SARAS 4.0 by one month i.e. upto 31st August, 2023. It may be noted that only in respect of following categories of application the date is extended:-

- I. Extension of Affiliation
- II. Section Increase
- III. Permission to increase/ decrease/ correction of land area of school
