Sub : Clarification regarding number of permissible sections.

In reference to this office earlier <u>circular no. 12 dated 24.03.2023</u> regarding NCFFS, in which permissible number of sections are laid down for Balvatika 1,2 & 3 based on the land area of the school, it is clarified that total number of section in a school shall now be considered from Balvatika 1 to class 12th.
