1. That Child Education Society is a registered Society under Act XXI of 1860 of Registration of Societies.

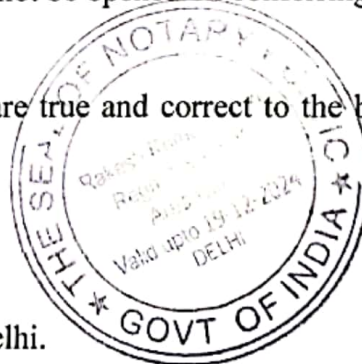

8. That State pattern Classes IX to XII running prior to the affiliation of CBSE would be sponsored at State Board Examination & State Pattern classes IX to XII will be closed in a phased manner & State Pattern classes IX to XII will not be opened on conferring upon Affiliation from CBSE.
