Subject: - Submission of the compliance(s) of conditions mentioned in the conditional grant of affiliation/ upgradation/ extension etc. under various categories in SARAS.

The schools are granted affiliation subject to certain conditions were imposed for adherence to the said compliances. The time period was mentioned in grant letters and it is found that the schools for whom the 06 months have already been expired, after grant of conditional affiliation for submission of online compliance, are given a last chance to submit compliance upto 31st March, 2023 in SARAS portal without any financial penalty. Thereafter, financial penalty shall be levied on the schools and may also lead to barring of schools from registering the LOC of students in class X & XII as well as registration in class IX&XI as the case may be.

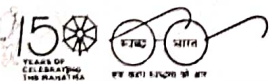
