**SUB: RESCHEDULING COMMENCEMENT OF NEW ACADEMIC SESSION FOR CLASSES IX TO XII IN THE SCHOOLS AFFILIATED WITH THE CBSE TO 15<sup>TH</sup> APRIL OF THE YEAR - REG.**

Sir/Madam,

Central Board of Secondary Education conducts the Class XII examination from 1<sup>st</sup> March and continues till the middle of April and the class X examination in March every year but the evaluation continues till the end of April, depending on the date of the examination of the subject concerned. The Board is committed for the efficient and smooth conduct of Class XII & X examinations with accuracy and fairness. It is also committed for careful marking of answer scripts and timely declaration of results.

You are aware that the evaluation of answer scripts is a massive task and the quality of evaluation is a concern of the Board at all times as the result has a life long impact on the career of the examinees. To enable the examinees to venture into higher studies or for pursuing professional and vocational courses, it is essential that the results are declared timely which is feasible only when the schools depute the qualified teachers in adequate number for the evaluation work.

In the past it has been observed that some schools under one pretext or the other do not relieve the teachers for evaluation work, which is an undesirable practice. One of the reasons quoted is commencement of new academic session from 1st April onwards.

Though, as contained in the Affiliation Bye-laws "Session" means the period of twelve months duration, when instruction is provided to the students, normally April to March, you are requested to re-schedule commencement of new academic session for Classes XI and XII to be from 15<sup>th</sup> April of the year. In doing so, the schools will be in a

position to depute adequate number of PGTs for evaluation work without disturbing the functioning of the school, the eligible teachers assigned the evaluation duty will be able to perform the assigned duty and the Board will be able to get teachers in adequate number to ensure that the evaluation work is got done as per its schedule in a judicious manner and which in turn will also enable the Board to declare the results in time.

The change be effected from the academic session 2014-2015.
