**Sub: Amendment/Addition in Affiliation Bye-Laws of the Board-reg.**

Sir/Madam,

Consequent upon recommendations of the Affiliation Committee made in its meetings held on 06.12.2013 and subsequently approval of the Governing Body of the Board in its meeting held on 11.12.2013, the following amendments/additions in Affiliation Bye-Laws of the Board have been made by the Board:-

Existing Rule 30.1	Amended Rule 30.1
<p>Notwithstanding anything contained in these rules or otherwise every employee including Head of institution shall retire from service on attaining the age of 60. However if the age of superannuation falls during the academic session, the concerned employee will retire at the end of the academic session.</p> <p>Provided further that if such employee is a recipient of National/State/CBSE Teachers Award. He may be considered for a further extension of service for two years after attaining the age of superannuation provided he is medically fit and is prepared to serve the school. The school managing committee after considering such case of extension of service, shall forward the details to the Board.</p>	<p>Notwithstanding anything contained in these rules or otherwise every employee including Head of institution shall retire from service on attaining the age of 60. However if the age of superannuation falls during the academic session, the concerned employee will retire at the end of the academic session.</p> <p>Provided further that if such employee is a recipient of National/State/CBSE Teachers Award, he/she shall superannuate from service on attaining the age of 65 subjected to meritorious service, good health and good conduct.</p>

The above amendment is brought to the notice of all concerned.
