NOTIFICATION

**Subject: Clarification on Board's circular dated -1.04.2019 regarding the Addition of Fee /Penalty provisions in Affiliation Bye-Laws-2018 in respect of additional subjects i.e Yoga, Introduction of Artificial Intelligence and Early Childhood Care Education**

The Board has issued Notification dated 01.04.2019 with regard to fee/penalty provisions in Affiliation Byelaws- 2018. This Notification has been issued with a view to introduce uniformity and transparency in dealing with all cases that come to the Board for one-time exception decisions.

In this connection, as per provision mentioned in Rule 10.4.1 of Affiliation Bye-Laws, it is the responsibility of the school to apply for additional subjects with requisite fee as per time frame. Further, the schools that miss the opportunity to apply for Additional Subject online with requisite fee as per time frame, the Board has incorporated On Demand Fee provision for Introduction of Additional Subject in the said notification.

However, in order to promote the skills-based education and the value of project related work, the competent authority has accorded necessary approval that On Demand fee provisions as mentioned in Notification dated 01.04.2019 **will not be applicable to three additional subjects which are Yoga, Introduction of Artificial Intelligence and Early Childhood Care Education**. Therefore, the schools that apply for any/ all of these three subjects are not required to pay additional fee/penalty mentioned in notification dated 01.04.2019 for introduction of these subjects from session 2019-20.

Further, the schools are required to abide by the conditions mentioned in Board's circular dated 09.03.2019 in this regard.

This is for information to all concerned stakeholders.
